  - Have 4 locations around San Francisco and want to open location in Noe Valley since they get patients from Noe Valley
  - They are looking to open a location in ground floor where usual retail spaces are since it would be a Urgent Care facility they believe they need to be on ground floor

- They see about 60-80 people a day. Appointments scheduled online. When you check into your appointment they will give you the ability to walk around the neighborhood and they send you a text when you are next to be seen.
- The urgent care facility will be able to conduct x-rays or IV if needed.
- No insurance needed to be seen but they take most insurances.
- No contracts needed
- They can immediately screen if someone is in need for a emergency department for instance in a heart attack situation they will begin early procedures for them, ask where they want to go and call ambulance for transportation.
- They are seeking a letter for conditional use hearing to open a Golden Gate Urgent Care facility on the 24<sup>th</sup> street commercial corridor. A motion was made by N. Demopoulos and seconded by D. Sheehan-Meyer, motion carries and approved unanimously.
